

SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM  
FOR VILLAGE PLACE CONDOMINIUMS

The Declaration of Condominium for Village Place Condominiums, recorded in Official Records Book 2684, Page 3598, Walton County, Florida (hereinafter the "Declaration") is amended this 17<sup>th</sup> day of July, 2012, pursuant to Article 13 of the Declaration by the requisite number of unit owners as defined in Article 13, for themselves, successors, grantees, signees and transferees.

WITNESSETH:

WHEREAS, the Declaration was recorded on August 11, 2005 at Official Records Book 2684, Page 3598 of the Public Records of Walton County, Florida;

WHEREAS, the Declaration was amended on January 4, 2011 as reflected by the Certificate of Amendment recorded at Official Records Book 2857, Page 3704 of the Public Records of Walton County, Florida;

WHEREAS, pursuant to a duly-noticed special meeting of the members of Village Place Condominium Owners' Association, the requisite number of members have voted to amend Paragraph 17.3 of the Declaration to restrict the leasing of units at the Condominium to a minimum period of no less than 3 days.

NOW THEREFORE, for good and valuable consideration, the Declaration is hereby amended as follows:

I. Section 17.3 entitled "Rental of Units." is hereby amended to read as follows:

17.3. Rentals of Units. Owners of Units shall be entitled to rent or lease their respective Units from time to time as they wish, for such term or period of time of no less than 3 days, ~~including a daily rental~~, and upon such terms and conditions as the respective Unit owners may determine, provided that in any event, any rental arrangement must specifically obligate the renter or tenant to abide by the terms and conditions of this Declaration, the Articles and By-Laws of the Association, and all terms and conditions of the Master Declaration, as well as all pertinent rules and regulations adopted from time to time. In addition, Unit owners, renters and tenants shall in all respects comply with provisions of state and local laws and ordinances in connection with rentals and leases of units. Unit owners shall be responsible for advising renters and tenants of applicable rules and regulations pertaining to use of the Condominium

property; as adopted from time to time. Guests of Unit owners; including invitees, renters, tenants, and lessees, shall not bring any pets or animals whatsoever upon the Condominium property.

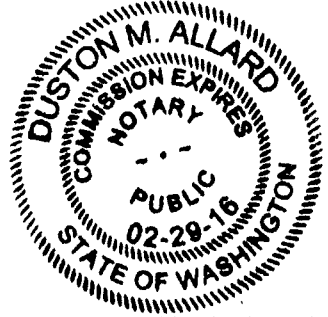

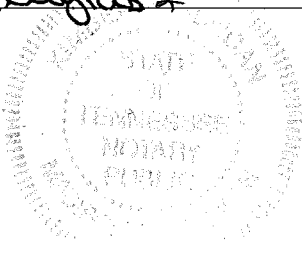
